# Initial Narrative By Bradley Brunken, 10/06/22 04:32

On 10/05/2022, at approximately 2236 hours, I, Officer Brunken, was on duty in the City of Baraboo, County of Sauk, in full-duty uniform and operating marked SUV 46. I was requested to call into Dispatch. I called into Dispatch and was put into phone contact with Teflon L. Lee. Lee stated that he had been in the area of the hospital, when he was pulled out of a vehicle by subjects who had a flamethrower. I advised Lee that I would respond to his address and speak to him about the incident.

Prior to the call, I was advised by Officer M. Pichler that there was a social media post in reference to someone with a flamethrower who had pulled juveniles out of a vehicle.

I responded to 825 12th Street, where I contacted Lee and Lee and Lee advised that they drove past the house (1106 Tandom Trail) and they observed a subject with what Lee described as a flamethrower. Lee stated that the subject was holding a light in one hand and the flamethrower in the other. Lee stated that they turned around at the

end and went back down Tandom Trail. As they were trying to leave, the subject shot flames into the air, over the road. Lee stated that they, the occupants of the vehicle, attempt to leave the area. Lee states that James J. Langkamp and two other subjects jumped in front of the Jeep and the Jeep stopped. The subjects blocking the roadway then started velling at the occupants of the Jeep to get down, turn off the engine, and open the doors. The operator, turned the motor off. They then were ordered out of the Jeep. Lee and got out of ran from the vehicle. Lee and the vehicle. and were told to get on the ground and they got down on their knees, like they were being arrested. Lee stated there may have been a female there. Lee stated that the girl there told her dad to calm down. The subjects then started to guestion both Lee and and told them they have been being stupid all weekend. Lee stated that they had gone to the area to see how bad the house had been hit. Lee stated that the subjects did let them get back into the car and leave. Lee stated that he knew the girl who lived at the house and identified her as Lee confirmed that Langkamp had been at the scene with a flashlight. The father was described to be wearing camouflage and was military-like. Lee stated that was driving, was the front passenger, Lee was sitting on the driver's side in the back seat, was in the passenger side back seat, and was sitting in the back seat in the middle. Lee stated fled the scene on foot and that and himself stayed at the scene. Lee was that and stayed in the Jeep or not. Neither Lee or consented to any of the actions that were taken not sure if against them during the incident. Lee stated that they had been told that they were under citizen's arrest. There were no injuries. Lee stated that he was thinking "what is he going to do?" and "I hope that he isn't going to hurt me now" when the incident was occurring. I confirmed that Lee believed that he was going to be hurt. Lee replied by saying, "Yeah, he had a flamethrower". Lee stated that he did not do anything but just drove past the house. Lee confirmed that Langkamp had jumped in front of the car, questioned the juveniles, and told them that they had go to home. Lee stated that there was a lot of screaming and the "military guy" was screaming the most. Lee stated that the group of people were waiting in the lawn. Lee and were told to advise their parents of the incident.

by cell phone. told me that they had been driving and admitted to toilet I contacted papering for homecoming. stated that he saw some people with flashlights and possibly firearms. stated that they turned around in a driveway. stated that they then got "swarmed" in their Jeep and were ordered to get out of the car. The subjects told them to shut the car off. The subjects pulled two people out of the car stated that a flamethrower was then pointed at their head. The and told them to get onto their knees. was ordered out of the car. subjects then started to question them. stated that the just stood there stated that they were accused of smoking marijuana but denied any marijuana in the with his hands up. vehicle. stated they were told to not come back, as they were on their knees. They then left and saw that the subject with the flamethrower shot more flames into the air. stated that they were swarmed by five to eight identified one as "Kolmar" and the other as the athletic director. people. was able to tell me that "Kolmar" was the father to admitted that they were planning on toilet papering house. described the flamethrower as looking like a gun. stated that he remembered the flamethrower only being confirmed who was in the vehicle. shot off when they were leaving. stated that he thought he was going to be arrested at first during the incident. continued by stating he was scared for his friends' lives. stated that he did not consent for any of the actions to be taken against him. was advised to tell his parents about the incident.

stated that his friends said to go look at Kolar's house. They turned I contacted by cell phone. onto the street and someone "came out of nowhere with a flamethrower". conducted a "Y-turn", due to the street being a dead end. stated that a group of people surrounded the vehicle with flashlights. The people put the flashlights in their faces and yelled at them to get out of the car. stated he was told to shut the car off, so stated he and Lee were told to get out and get on the ground. he shut the car off. stated that they were yelling at them and that they were told they were being detained. stated that they were made to get out stated that they got accused of smoking marijuana. stated that they were then told to "get of the car. out of here" and they left. stated that he did not give consent and confirmed who was in the Jeep. stated that he was scared that either the car would get damaged or someone was going that he was not hurt. to get hurt. stated that Langkamp was involved. stated that the thought that Lee had said that stated there was three or four people involved, with another person dad had the flamethrower. standing off to the side.

Officer Carroll and I responded to 1106 Tandom Trail, where we contacted John A. Kolar. I spoke with Kolar briefly about the issues he had been having. I asked Kolar what had happened tonight and he asked what I meant. Kolar then said it was more of the same. Kolar stated he did yell at the kids to get out of here and go to their homes. I asked Kolar if he stopped any of the juveniles. Kolar stated that he stopped some kids down on Tillberry. Kolar did admit that he yelled at another group of kids and told them to get out of here. Kolar stated that there was a Jeep full of kids that was racing. Kolar stated that his neighbor stopped the Jeep. Kolar stated that his neighbor had stopped him. Kolar stated it was his neighbor, William D. Bowden, and Langkamp. Kolar stated that he came from his house. Kolar stated

that Langkamp made them stop. Kolar admitted "we told them to get out of the car." Kolar stated they questioned them. Kolar stated they told them they were not welcome in the neighborhood. Kolar stated that several people told them to get out of the car. Kolar stated they confronted them about marijuana. Kolar stated that he did not think anyone told the juveniles to get on their knees and that the juveniles just did it. I asked Kolar about who had the propane torch. Kolar hesitated and stated he did not know. Kolar admitted that it is not his right to order anyone out of their vehicle. I told Kolar that he cannot take the law into his own hands and Kolar stated that he agreed.

At this time, I told Kolar that he was under arrest. Kolar's wrist's were placed into handcuffs. I checked them for fit and double-locked them. I informed Kolar of what he was being arrested for. A search of Kolar produced nothing of law enforcement interest. Kolar was escorted to my squad car, where he was placed into the back seat. I was requested to contact to come to the house for the squad was moved to a position where it could be monitored during my next contact.

Officer Carroll and I proceeded to contact Langkamp at his residence, 1112 Tandom Trail, which is next to Kolar's. I spoke briefly with Langkamp about the issues they had been having in reference to homecoming. Langkamp stated that a Jeep raced down and turned around on Tandom Trail. Langkamp stated that he was down at the other end, by Surrey Lane, taking pictures. Langkamp stated that the guy from two houses down was in the middle of the road. Langkamp demonstrated how the man was standing, by spreading his legs and putting his arms out wide. The man allegedly yelled at the vehicle to stop. Langkamp stated it was Bowden who had stopped the Jeep. Langkamp stated Kolar had a device with a flame coming out of it. Kolar started to yell at the juveniles in the Jeep. Langkamp stated that Kolar yelled at them to get out of the car. Langkamp stated that Kolar yelled at the juveniles to get on the ground. Langkamp admitted that he went over by the juveniles, who were down on their knees, and he recognized them. Langkamp admitted that he yelled at them a bit and told them to get out of here. Langkamp denied being in the street and stopping the Jeep. Langkamp denied knowing that the flamethrower was going on but admitted again seeing Kolar with the device. Langkamp denied being a part of the incident and stated he was the reason the incident ended.

I told Langkamp that he was under arrest. Langkamp's wrists were placed into handcuffs. Officer Carroll checked them for fit and double-locked them. I informed Langkamp of what he was being arrested for. A search of Langkamp produced nothing of law enforcement interest. Langkamp was escorted to Officer Carroll's squad and he was placed into the back seat.

I contacted Kolar in the back seat of my squad. I read Kolar his Miranda Rights from a card that I carry in my vest. Kolar did not have any questions and understood his rights. I requested Kolar for a consent search of his residence. Kolar denied owning a torch and stated he had a heater for his garage. Consent was not given to me.

Custody of Kolar was transferred to Deputy Barnes of the Sauk County Sheriff's Department. Deputy Barnes transported Kolar to the Sauk County Jail on my behalf. Officer Carroll transported Langkamp.

I spoke with the incident. In reference to speaking with her daughter, who was still in the house and had witnessed the incident.

Officer Pichler and I contacted Bowden at his residence (1100 Tandom Trail). I read Bowden his Miranda Rights from a card that I carry in my vest. Bowden did not have any questions and understood his rights. Bowden stated that there were kids speeding through the area and taunting them. Bowden stated he came outside and he saw a vehicle driving at a high rate of speed. Bowden stated that "it went down here" and pointed toward the dead end. Bowden stated that he yelled, "Stop!" at them and that they were going to kill somebody. Bowden stated that the vehicle did stop and that his neighbors came by the vehicle. Bowden stated that the other neighbors told the occupants to get out of the car. Bowden advised that they told them that they can't be driving like that in the neighborhood. Bowden then allegedly went back inside and had only been outside for about ten minutes. Bowden stated that the vehicle "hammered" on it. Bowden stated that it got him so upset. Bowden admitted that he jumped out in the road and yelled, "Stop it!" Bowden then stated that he was by the edge of the road so that he did not get run over.

Bowden admitted that he saw a flamethrower and flame/fireball. Bowden stated that he did not know what it was but saw it when he was talking to the vehicle occupants. Bowden showed me that the flame was approximately two feet tall with his hands. Bowden guessed that Kolar had the flamethrower, but stated it could have been Langkamp. Bowden stated that he was 50 to 75 feet away from the flames. Bowden saw the flames three times. Bowden remembered hearing a hissing sound from the flamethrower. Bowden stated that the others were already at the car window prior to him getting there. Bowden stated that Kolar was ordering them out of the car. Bowden admitted that he told the juveniles that they were in a lawful detainment. Bowden stated that his daughter arrived home and he told her that he was protecting his neighborhood. Bowden stated that his daughter told him to stop it. Bowden stated that he then left and went inside. Bowden stated that he did not stay for the juveniles getting out of the car. Bowden stated

that he was not there when the juveniles were put onto their knees. Bowden mentioned that Brian G. Getschmann may have been involved. Bowden denied ever having thoughts of ordering people out of their cars and on to their knees. Bowden admitted to telling the juveniles that it was a detainment and stated that he thought a detainment was what it was. I asked Bowden why he told the juveniles that it was a lawful detainment. Bowden responded by saying that that he was justing trying to tell them what it was. Bowden stated that he was not sure what Getschmann had done during the incident. Bowden stated that again he believed the flamethrower was possessed by Kolar. Bowden just remembers Getschmann was there.

I then told Bowden that he was under arrest. Bowden's wrists were placed into handcuffs. I checked them for fit and double-locked them. I informed Bowden of what he was being arrested for. A search of Bowden produced nothing of law enforcement interest. Bowden was escorted to my squad and he was placed into the back seat. I fastened the seatbelt for Bowden.

I contacted Brian G. Getschmann at this residence (2018 Surrey Lane). Getschmann introduced himself as being a Police and Fire Commission member. Getschmann stated that he was aware of a vehicle being stopped. Getschmann stated that the Jeep came down the street and turned onto Tandom Trail at a high rate of speed. Getschmann stated that the particular car was extremely dangerous. Getschmann stated that they stood in the road and stopped the car. I asked who and Getschmann stated, "Neighbors, everybody, there were lots of people." Getschmann stated that he went down there. Getschmann stated that "they" told the occupants to get out of the car and they talked to them. Getschmann stated he did not talk to the kids and denied involvement. Getschmann stated he did not see any fireballs. Getschmann claimed that the only thing dangerous in three nights, that he has observed, has been the kids. Getschmann stated that he could not tell me for sure who ordered the juveniles out of the car. Getschmann stated he was standing right by the vehicle but was not one of the ones who did anything. Getschmann stated he did not think he saw a fireball but someone had a big, bright flashlight. I asked if he remembered the juveniles being ordered to their knees. Getschmann stated yeah and stated they were told to get out of the car. Getschmann stated that one juvenile stated okay, okay, I will get down on my knees. Getschmann stated that the event lasted approximately about a minute. Getschmann stated that they, the neighbors, had been screaming at the juveniles to get out of the car. Getschmann stated that his opinion, everything that he saw, they 100 percent deserved. Getschmann stated that whatever they did, meaning his neighbors, is justified due to the fact that somebody was going to get hurt.

I then transported Bowden to the Sauk County Jail without incident. I completed all necessary paperwork at the jail. I transferred custody of Bowden to jail deputies.

At the jail, I read Langkamp his Miranda Rights from a card that I carry in my vest. Langkamp did not have any questions and understood his rights. I asked if he had seen where Kolar had gone after the incident. Langkamp did not recall. I asked Bowden if he remembered seeing where Kolar went after the incident and he also had not seen where Kolar had gone.

# End of report. 213 Supplemental Narrative By Ian Carroll, 10/06/22 06:49

ON 10-05-2022, I, Officer Carroll, was on duty for the Baraboo Police Dept. I was wearing full-duty uniform and operating marked patrol squad 47. At approximately 10:30 p.m., I was contacted by Officer M. Pichler, who requested to meet with me and share some information that had been brought to his attention. I made contact with Officer M. Pichler in the parking lot of St. Clare Meadows Memory Care. In speaking with Officer M. Pichler, he advised me that he had gained some information from some students at the Baraboo High School of an incident that occurred earlier in the evening on Tandom Trail. Officer M. Pichler continued on to state how approximately three adult males had removed multiple juveniles from a vehicle that had been traveling on Tandom Trail and forced them onto the ground, kneeling in what Officer M. Pichler described as "execution style". Officer M. Pichler was able to make phone contact with a male/juvenile, identified as



In speaking with **sector** he explained how he and some of his fellow classmates had been in the area of Tandom Trail in particular 1106 Tandom Trail where one of their fellow classmates, identified as

resided. It was explained that this residence had been subject to numerous toilet papering and other homecoming celebrations during the past week. went on to state how he and some of his classmates had parked their vehicle at Steinhorst Park and made their way up to Tandom Trail, following a nearby cornfield. When they arrived in the area, they observed father, identified as

### John A. Kolar

becoming very irate and yelling at a group of students who had been driving a black Jeep. Continued to state that the students were taken out of the vehicle and "told to get on the fucking ground". The students were described as kneeling on the ground, with their hands up in the air. Control also described John as displaying, what he described as a, "flame thrower". Control also stated that John, who he knew from past contacts, was also in the company of a James Langkamp, who he recognized as the athletic director for the Baraboo High School. During this encounter, observed John yelling at the students and firing off the flame thrower. When asked to elaborate, stated how he saw a large flame come out from the device that John had been carrying. Stated that he and his other friends, along with other students who had been in the area, fled in fright after witnessing this. Contact was then ended with

After ending the phone conversation with Officer Brunken advised he had received a call, similar in nature, from a

stating that he had been pulled out of his vehicle by people with "flame throwers". After speaking further with Officer M. Pichler and Officer Brunken, it was determined that Officer Brunken and I would take primary on this investigation due to possible conflict of interest involving Officer M. Pichler.

Officer Brunken and I then responded to 825 Twelfth St., to make contact with Teflon. Upon arrival, Officer Brunken and I made contact with Teflon and another male, identified as

outside of the apartment complex. In speaking with Teflon, he advised that he had been riding in a vehicle that had turned on to Tandom Trail. As they passed John's residence, they observed a male, who they identified as John, shoot the flame thrower up into the air. Teflon stated he and the other passengers in the vehicle were surprised by this and also frightened because "it's a fucking flame thrower". Teflon continued on to state that as they approached the dead end cul de sac, they turned the vehicle around and as they were driving back toward the main street, John again shot off the flame thrower this time toward the ground. Teflon went on to state that another male, who he recognized as James Langkamp and another male stepped in front of the vehicle that they had been riding in and told them to stop. The vehicle did come to a stop and all the occupants in the vehicle were ordered out of the vehicle and to kneel on the ground. Teflon stated that he and the other passengers did get out of vehicle and kneel down on to the ground with their hands in the air. Teflon continued on to state how once they were out of the vehicle and onto the ground with their hands in the air, they were approached by John and James and questions were being directed toward them. began to speak up telling her father to calm down. Officer Brunken While this was going on, John's daughter, did ask Teflon how he left. Teflon stated "they" told them to get back in the vehicle and to leave the area. Teflon also explained how they had heard how John's address had been "hit" the previous night and they were in the area to go and see what necessarily had been done. Teflon did deny any malicious intent such as toilet papering or any other type of vandalism.

When asked who else was in the vehicle with him, Teflon identified a

who was also present, stated that he and another male ran when they had been ordered out of the vehicle. Officer Brunken did ask Teflon if, at any point, gave anyone permission to remove him from the vehicle and have him kneel on the ground. Teflon stated that he did not and went on to state how the adult males stated that they were conducting a "citizen's arrest". I then asked Teflon what possibly John and James and the other neighbor might say when we went to go talk to them to elaborate. I asked Teflon if they would report him and his friends doing anything malicious. Teflon admitted that they were driving "a little reckless" but followed up stating he didn't know anybody who wouldn't when they had a flame thrower going off and directed toward them.

Officer Brunken did ask **sector** if there was anything else that he felt was important to add. **Sector** stated that he had nothing further to add and that how and he and another male, who had been riding in the vehicle were running away when they were being directed out of the vehicle, so he did not hear much about what was being said. I did inquire with Teflon and **sector** about the involvement of James Langkamp as he had been specifically identified. Teflon stated that James had been the one who had stepped in front of the vehicle to stop it and had been questioning them, while they were on the ground, but he was unable to hear what exactly what was all being said due to the amount of yelling that was happening. Officer Brunken and I had no further questions for Teflon and **sector** and contact with them was ended.

Officer Brunken and I then made contact with Officer M. Pichler. In speaking with Officer M. Pichler, he advised me of a female who may have further information regarding this incident. This female was identified as

I asked to elaborate for me about the flame thrower. **Security** stated that she believed it was a "backpack one" and that she saw how John was holding on to something but she could not actually verify what this was. stated that she and her friends ran from the area and got back in their vehicle and began to drive away. While they were driving stated that one of her friends, who she identified as away,

had observed the flame. I asked **server** if she recognized any of the other adults, who were on scene, and she told she did not only that she recognized John from his figure and his voice as his daughter, **server** plays volleyball with

reported feeling "dumb struck" and being "in shock". The also reported hearing screaming and she and her friends almost stopped the vehicle because they did not know what was going to happen to the other males who were in the vehicle who were on the ground. I did ask the other males who may have been in the area at the time. She did inform me that she believed Teflon Lee, who I had previously spoken to, was in the area and she was going off this information based off his location on a Snapchat map. I collected the time information and asked her if she had any further questions for me. If the stated she did not have any questions and her parents did not have any questions for me either at this time. I thanked the for speaking with me and contact was ended.

I then made phone contact with if I could ask her a few questions and she agreed to I asked that I had previously spoken with and that the two were together near Surrey Lane do so. I informed and Tandom Trail. I asked her what she could tell me about this. stated that while she was near the area with her friends, she observed a black, in color, vehicle go down Tandom Trail. As the vehicle turned around, it was approached by all the neighbors and other parents, specifically father, John Kolar, where they began to yell and swear at the occupants of the vehicle and order them out and on to the ground. I then asked how she stated she plays sports with **state** and that he comes to their games and that's father. knew it was where she recognized him from. continued on to say that there was many flashlights being shined down onto the occupants of the vehicle, who had been ordered out, and that there was a lot of yelling but this eventually subsided. stated she was unsure of who the occupants of the vehicle were, however she along with and her other friends, continued to watch. I did ask if she had any observed anything pertaining to a flame thrower, which had been previously mentioned. stated she did not actually observe a flame thrower and that she did observe something being pointed at the males, who were on the ground, but she believed that to be only flashlights. continued on to state how she was aware how a flame thrower had been mentioned by other people. I did ask if she recognized any of the other adults who were involved with the vehicle and the occupants and she told me that she did not and that how she only recognized dad, again pointing to how he comes to their games. I did ask if she remembered what father was wearing and she told me that she believed he had been wearing camouflaged type clothing. I advised I had no further guestions for her and thanked her for speaking with me. Contact with her was then ended.

I then made contact with Officer Brunken and informed him of my conversations with **sector** and **sector** Officer Brunken advised me that he had spoken to others who had been in the area and it was agreed that all the stories that we had received up to this point seemed to match up with one another. After speaking with Officer Brunken further, it was determined to proceed over to **1106 Tandom Trail** in an attempt to speak with John regarding this incident.

At approximately 12:45 a.m. Officer Brunken and I were able to make contact with John Kolar at his residence. He advised that it has been an eventful past couple of nights mentioning how there have been numerous vehicles with over 20 plus kids running around the neighborhood. John also mentioned how many of his other neighbors were also feeling irritated with an increase of traffic, the number of kids running through the neighborhood, toilet papering and other malicious activities that have been going on. Officer Brunken asked John what the plan was that had been formulated with the neighbors in order to confront the kids that had been coming through the neighborhood. John stated how they had been in constant communication with one another and talking and made mention of "the hose worked last night" pointing to a garden hose laying on the front lawn. John was asked if there had been anything that happened specifically tonight. John seemed to dance around the question saying that it was a lot of the same that had been going on the last previous nights. I again redirected the question to John asking if he had spoken with any of the kids coming through his neighborhood. John was asked if this had meant in speaking with him in terms of talking with them or yelling at them. John stated, "We did yell at them telling them to get out of here and go to their homes."

John was asked if he stopped any vehicles and he told officers how he had stopped a vehicle down on Tillberry Dr. and after speaking with the occupants of the vehicle, they informed him they were only toilet papering and that he ended contact with him. Officer Brunken then advised that John that he would not be speaking with him at 1 a.m. if he didn't believe nothing more happened than just talking to them. John then spoke about stopping a Jeep full of kids because it had been racing up and down the street. John was asked who stopped the Jeep, in particular, and he told us his neighbors and named James Langkamp and William Bowden as having stopped the Jeep. John went on to state how James, in particular, had stopped the vehicle and how James is familiar with some of the kids who were in the vehicle and how they all had them get out of the vehicles. John went on to state how James told the kids that they were not welcome in the neighborhood and to get out. When asked who told the kids in the vehicle, once they were out, to get down on their knees, John told us that he did not know and that he didn't believe anybody did. When asked about a propane torch or flame thrower, John denied knowing anything about this. I did point out that there were multiple groups of kids in the area all seemed to be uninvolved from each other besides the common fact that they were in the same area at the same time and they are reporting that a flame thrower or flame had been displayed. John again denied any knowledge of this. I followed up with this guestion by asking John what gave him or anybody else the right to stop a vehicle on public property and tell people to get out of the vehicle. John replied that he did not believe it was his right to do so. I then pointed out to John that we had multiple people pointing out him in particular as ordering the occupants of the vehicle out and on to the ground. John stated that it had been an eventful evening but that he did not recall ever saying anything vulgar to them. John was informed that while we understood that he may be feeling frustration and not wanting to have his house vandalized, that it was believed a line had been crossed and things had gone too far. John agreed with our statement.

At this time John was informed he was going to be placed under arrest. John was assisted to his feet and his arms

directed behind his back. Officer Brunken then secured John in handcuffs, double locked them and checked for it. John did state that his 15 year old daughter, was still inside the residence. John was informed that this would be attended to as well. Officer Brunken did inform John of the charges being leveled against him including disorderly conduct, recklessly endangering safety and false imprisonment. John was then escorted to Officer Brunken's patrol squad and secured in the rear passenger section. I did turn back to the residence and attempted to make contact with in order to gain some shoes for John, along with a wallet and cell phone. I did ring the doorbell multiple times, as well as knock on the door, however I did not receive a response. I informed Officer Brunken of my findings and he informed me that contact would be made with John's ex-wife and work mother for her to respond.

Officer Brunken then proceeded to John's next door neighbor to the east, James Langkamp's residence. Officer Brunken did ring the doorbell of James' residence and a short time later, he answered the door. James verbally identified himself, and he was asked to speak with us on the front stoop. James did come outside to speak with Officer Brunken and me. In speaking with James, he admitted that it had been "an eventful week" estimating there had been approximately 14 to 15 kids in the neighborhood at one time. James went on to state that the majority of the kids had targeted John's residence and how John, at one point, the previous night sprayed them with the hose. Officer Brunken then asked James what happened tonight. James explained how there had been multiple vehicles in the neighborhood racing up and down the street many of them without headlamps on and running around corners at high rates of speed. James also made mention how they had received a heads up that the football team would be coming over to target their neighborhood. James went on to state that on tonight's date, he had been down at the end of the street taking photographs of vehicles with kids inside and taking pictures of their license plates. James then brought up the black Jeep that had come down Tandom Trail. James stated as the vehicle turned around, the neighbor, just to the west of John, identified as William Bowden, had stepped out into the middle of the road and spread his arms out wide in an attempt to stop the vehicle. James went on to state that once the vehicle had stopped, he looked over at John and he observed "this flame coming out" and used his hands to elaborate. James went on to state after the vehicle had stopped and the flame had been shot out, how John approached the vehicle and ordered the kids to get out of the vehicle and lay on the ground. James did admit that the kids "really weren't doing anything". James stated he did recognize two of the males who got out of the vehicle and he went up to them and he began guestioning them stating why are you guys here and how they needed to leave. In speaking with James, he seemed to downplay his role and involvement in this incident. When confronted with this by Officer Brunken, James denied having stepped out into the street and stopped the vehicle stating that he "100 percent" did not do any of that.

I informed James that multiple uninvolved people who happened to be in the area had mentioned him specifically and his involvement. I went on to state while I understand the frustration that I believed everything had gone too far and that a line had been crossed and asked James if he agreed with me. James did agree that things had gone too far but denied knowing that John was going to use the flame thrower. It should be noted when speaking about the flame thrower, James put his head down and shook his head back and forth. James went on to state that he did not know how John was going to react and claimed that it was he, who had calmed everything down. In speaking with James, it seemed that he wanted to separate himself from the actions of John. Officer Brunken then made comment of how after observing how John was treating the kids such as pulling them out of the vehicle and having them get down on their hands and knees and displaying the flame thrower, that when one went to intervene as this is going on too far and stop what was going on. James then spoke about how he used his camera to take pictures of license plate and used his flashlight and when he saw what was going on with the boys were out of the vehicle and on the ground, he walked over there to talk to them, James made no mention of making any attempt to separate the juveniles or John from one another. James went on to state how he told the juveniles multiple times to leave and to get out of the area. When asked if the multiple witnesses, naming him as the person standing out in the roadway stopping the vehicle and telling the kids to get out, were lying, James stated that all of them were lying.

At this point Officer Brunken informed James he was under arrest. James seemed surprised by this and he was directed to turn and place his hands behind his back. When I took control of James left side, I noticed tension and I told him not to tense up. I then secured James in handcuffs, double locked them and checked for fit. James was informed he was being placed under arrest for disorderly conduct--party to a crime, reckless endangering safety--party to a crime and false imprisonment--party to a crime. James was escorted to my patrol squad and secured in the rear passenger section.

I then returned to his residence where I made contact with James' wife and requested a pair of shoes, his wallet and cell phone. James' wife was visibly upset by what was going on and I attempted to answer her questions to the best of my ability. I was then provided with a pair of shoes, James' cell phone and wallet, along with a change of clothing. Once these items were collected, I returned to my squad. I then briefly spoke with James about the potential next steps in this process. I then completed jail transport sheet, proxy and scripts for disorderly conduct--party to a crime, false imprisonment--party to a crime and second degree reckless endanger safety--party to a crime. James was then transported to the Sauk County Jail where he was turned over to jail staff without incident.

I then cleared from the jail and proceeded back to 1106 Tandom Trail where I made contact with Officer M. Pichler. In speaking with Officer M. Pichler, he advised me that a third male, William Bowden, had also been placed under arrest and would be transported to the Sauk County Jail by Officer Brunken. Officer M. Pichler would be making contact with the District Attorney's office in an attempt to obtain a search warrant for the flame thrower that had been displayed during this incident. I remained on scene to assist as needed. After some time, it was determined that a search warrant would not be granted at this time and officers cleared from the scene. My body worn camera was activated during my contact with all those involved that I spoke with and will be added into DEMS. This ended my involvement.

### INITIAL REQUEST:

On Thursday, October 6, 2022, we were requested by Baraboo Police Department administration to the Tandom Trail Street area and check to see if any of the residences in the area have any form of exterior cameras that may have caught the incident and recorded it (incident from night of Wednesday, October 5, 2022). They also wanted us to talk with any subject that resided in the area and see if they had observed anything regarding the incident last night.

Detective Oakeson and myself did go to the Surrey Lane/Tandom Trail area and walked the neighborhood, looking for exterior cameras and checking to see if anyone was home. We did make contact at a couple of the residences and found some residence that did not have anyone home.

### CANVAS OF THE NEIGHBORHOOD:

### 1117 Tandom Trail

Detective Oakeson and I did first stop at 1117 Tandom Trail. We did not observe any exterior cameras on the residence. We attempted contact at the residence but found no one home.

### 1113 Tandom Trail

We stopped at 1113 Tandom Trail and did notice a Ring camera at the front door that faced due south. We attempted contact at the residence and again found no one home at this residence.

Sometime around 1 pm, I received a call from Nella Veloso, who stated that she lives at 1113 Tandom Trail and may have some information about last night's incident. Nella advised that the commotion they heard last night was the same commotion they heard Tuesday night, a lot of yelling. She went on to state that Tuesday evening, the Langkamps asked if they could park their third car in their (Veloso's) driveway so it doesn't get egged or toilet papered. Nella stated that they allowed James to park his vehicle in their driveway. Later Tuesday night after they went to bed, they heard the commotion outside. She and her husband got out of bed and went out to see if they had gotten hit by the toilet paperers. Upon going outside, they noticed that Langkamps got hit but they did not. The Velosos did not see anyone around but advised their street is only one block long so the people were gone. Nella went on to say that her bedroom is on the north side of the residence, so last night when they heard the commotion, they thought it was the same activity as Tuesday night, so they stayed in bed. Upon getting up Thursday morning and leaving for work, they did not notice anything out of the ordinary. Nella advised that when she heard the news about her neighbors, she checked her Ring camera but did not catch anything on video. The Ring camera only picked up a a young girl screaming "you suck ...", thats about it the rest is mumbled. I did thank Nella for her time and informed her that if she remembers anything else to contact the Baraboo Police Department.

### 2006 Surrey Lane

We stopped at 2006 Surrey Lane and noticed that they did have a Ring camera, but it was pointed in a due west direction and would not pick up any of the activity that occurred on Tandom Trail. We did make contact with a female subject, who identified herself as being Ashley Schreiber. We did identify ourselves as being detectives with the Baraboo Police Department and we were following up on the incident from last night. Ashley stated that she did not really hear anything. She reported that they had gotten home last night around 9:30 pm and had their windows open a little. She went on to say that they really don't have any windows on the north side of the residence, but when they got home they did observe some kids running through the lawn on the west side of Surrey Lane, and heard someone yelling at some kids south of their residence and also noticed a number of vehicles speeding up and down Surrey Ln with some of them having their lights off. Other than that they did not notice anything else. I did thank Ashley for her time.

### Other residences in the area

We did check other residence north, south, east, and west of the the Tandom Trail/Surrey Lane area for exterior cameras but were unable to observe any that would have possible caught any of the activity on camera.

On 10-6-22, at approximately 8:45 pm, I, Officer Brandon Sonn, was requested by Sgt. M. Wichner to conduct a follow-up interview of **Constant Schule Schule** 

to explain the events to me, as I was unaware of what took place. explained to me that he I asked (driver), **Teflon L. Lee** (left rear passenger), was in Jeep, with (right rear (middle rear passenger). advised that he was in the passenger front passenger), and advised me that they drove onto "the street" (Tandom Trail). advised that he and the other guys seat. were planning on toilet papering a nearby house. advised that they have a football game coming up and they said that he saw "him" shoot a "flamethrower" and he then told did not want to get suspended. that they need to turn around and get out of there.

to clarify who "him" was and advised it was John A. Kolar. I asked described Kolar as a dad of the home that they were going to "TP" (Toilet paper). said that Kolar had a "flamethrower" told then said that three males then surrounded the vehicle. that he did not want to be a part of that. later advised that Kolar was on the driver side, near with the flamethrower, a man named Will or William (believed to be William D. ### INITIAL INFORMATION

On 10-06-2022, following several meetings with school, city, and related officials to coordinate an organized informational approach to this event, I received an email from a male who was on-scene during this event; Brian Getschmann. In the email Getschmann wished to meet with me to discuss the event.

### MEETING WITH BRIAN AND JANE GETSCHMANN

On 10-06-2022, in response to Brian Getschmann's email, I drove to Getschmann's residence, located at 2018 Surrey Lane, which happens to be located on the northeast corner of Tandom Trail and Surrey Lane intersection. As I was speaking with Brian and Jane Getschmann in their driveway, we all observed a Madison News station media vehicle pull nearby. The Getschmann's were not comfortable speaking with me within the news media view so we traveled to my personal residence to speak. We met in my dining room with no others present other than me, Brian, and Jane Getschmann.

Brian and Jane Getschmann stated they were present during SOME of the event (after the stopping of the car occurred) and had questions as to the arrest of JIM LANGKAMP. Both Brian and Jane stated when they walked up to where the Jeep had been stopped; they observed JOHN KOLAR and WILLIAM BOWDEN yelling profanities at the occupants of the car and watched as the occupants were ordered out of the vehicle. Both Brian and Jane stated that LANGKAMP was present with KOLAR and BOWDEN; however, LANGKAMP did not ever raise his voice or use profanity toward the occupants of the vehicle. Both Brian and Jane stated that the occupants of the car and trying to get them to understand why they neighborhood was being watched so closely. Brian and Jane did state that; although it was very dark and difficult to see, they know the voices of LANGKAMP, BOWDEN and KOLAR so could easily discern which one was talking or yelling at any given time. Brian and Jane stated they believed KOLAR to be the most agitated/angry and BOWDEN to be the second most agitated/angry. Both stated they did not hear LANGKAMP yell or use any profanity.

I asked if either Jane or Brian had observed the use of any sort of "flame-throwing" or other similar type device and they stated that they walked up only after the vehicle was stopped and did not observe any flame at any point. It should be noted that the reports of the flame event were that it occurred at the moment of stopping the vehicle, so the Getschmann's walking up to the event AFTER the stop would have precluded them seeing anything prior. Both Jane and Brian stated it was too dark to see what could have been in KOLAR, BOWDEN, or LANGKAMP'S hands.

### VIDEO DISCOVERED

As we were speaking, JANE GETSCHMANN stated she had video recorded the event on a device while they were standing near the area. Both Brian and Jane stated the video is difficult to see because of darkness; however, the audio is clear. Again; Brian and Jane stated they know the voices of their neighbors LANGKAMP, KOLAR and BOWDEN so are aware of who is saying just what in the video. Both Jane and Brian stated that the entire event only lasted approx one minute before the group was sent on their way. I asked Brian and Jane if they would consent to me getting a copy of the recording and they stated it was on a flash drive down at their residence and I could pick it up whenever I wished. It should be noted that the Baraboo Police Department Detectives division had been earlier assigned to scan the neighborhood for any public/private potential video sources. I thanked both Jane and Brian for their assistance with the investigation.

### REVIEW OF VIDEO

I drove to the Getschmann residence and Brian handed me a USB Flash-drive. I again thanked him for his and Jane's assistance with the investigation. Upon my arrival back to the Police Department I did run a fast anti-virus scan on the USB drive and found nothing suspicious on the drive. I opened the video and the video starts with Jane Getschmann holding the camera and walking with Brian Getschmann up to where the vehicle is parked in the roadway. The video is very dark with some back lighting provided by the vehicles headlamps. The video remains pointed toward the vehicle and male voices can be heard yelling obscenities at the occupants of the vehicle. The male voices yelling obscenities appear to be from two males. (identified as KOLAR and BOWDEN by the Getschmann's) One voice states "shut the fucking engine off now" among numerous other profanity. Another male voice can be heard stating "put the fucking keys where he told you to put them mother-fucker". Again to re-iterate, the Getschmann's can determine which voice is attributed to each male as they have been long-time neighbors. There are no identifiable faces or people in the video due to darkness. At :53 seconds into the video a female voice can be heard yelling something to the effect of "Stop!" from a distance. This is thought to be the voice of JOHN KOLAR'S daughter.


Following an initial 15-20 seconds of profanity heard from two males, the voice of a third male can be heard talking to the occupants of the vehicle. This male voice is identified as LANGKAMP'S by the Getschmanns. This voice is very hard to hear, as it is much softer and does not contain profanity.

A dog can be heard in the background, which makes much of the audio difficult to hear because the speech is covered by barking. Following the discussion at 2:58 in the video, the occupants can be heard getting back into the vehicle and departing.

It should be noted that at no time in this video was any flame observed. Earlier reports indicate the flame to have occurred earlier than the Getschmann's arrived and started recording. Some reports were obtained; however, that the flame was again observed during the stop and contact at the car; again no flame or mention of flame can be seen in this video. Again at 3:28 in the video a male cab be heard stating "what the fuck are you doing get the fuck out of my yard". At 3:56 in the video a vehicle can be heard that sounds as if it is racing away on a roadway. The entire video is 4 minutes and 6 seconds in length.

### VIDEO PLACED INTO EVIDENCE

I uploaded the video from the USB drive into the "Digital Evidence Management System" used by the BPD for storage/viewing of video-based evidence. I also requested administrative staff forward a copy of this supplement to the Sauk County District Attorney's office. The District Attorney's office was also added to our online evidence software with rights to view the video.
